## **4.2 MOST IMPORTANT SYMPTOMS AND EFFECTS**

## 4.3 INDICATION OF ANY IMMEDIATE MEDICAL ATTENTION AND SPECIAL TREATMENT NEEDED

## **8.2 EXPOSURE CONTROLS**

#### **General Information:**

The level of protection and types of controls necessary will vary depending upon potential exposure conditions. Select controls based on a risk assessment of local circumstances.
